

ORANGE COUNTY BROADBAND AUTHORITY MINUTES

DECEMBER 19, 2017

At a Regular Meeting of the Orange County Broadband Authority held on Tuesday, December 19, 2017, beginning at 3:00 p.m., in the Meeting Room of the Gordon Building, 112 West Main Street, Orange, Virginia. Present: James K. White, Chair; R. Mark Johnson, Vice Chair; S. Teel Goodwin*; James P. Crozier, and Lee H. Frame. Also present: R. Bryan David, County Administrator; Thomas E. Lacheney, County Attorney; and Alyson A. Simpson, Chief Deputy Clerk.

RE: NEW BUSINESS

RE: APPROVAL OF MINUTES

On the motion of Mr. Frame, seconded by Mr. Crozier, which carried by a vote of 4-0, with Mr. Goodwin being absent, the Authority approved the September 12, 2017 Regular Meeting minutes, as presented.

RE: OLD BUSINESS

There were no matters for Old Business at this time.

RE: INFORMATIONAL ITEMS

RE: UPDATE ON THE PUBLIC SAFETY TELECOMMUNICATIONS PROJECT AND THE RURAL BROADBAND INITIATIVE

R. Bryan David, County Administrator, provided an update to the Authority on the status of the Orange County Public Schools' E-rate Fiber Optics network build; the draft public safety radio Request for Proposals (RFP); and the ongoing project development for fixed-wireless broadband and "middle-mile" fiber service. He noted that there had been a delay in reimbursing the contract from USAC, which was being reviewed. Mr. David also provided a brief update on work related to the Consolidated Public Safety Facility.

Discussion ensued regarding: the possibility of receiving an extension on the E-rate grant date since the payments had not been processed; the issues with the USAC reimbursements across the Commonwealth; management of the School Board's expectations related to the site visits for the public safety radio RFP; and potential tower locations.

The Authority took the information regarding the Public Safety Telecommunications Project and Rural Broadband Initiative under advisement, and there was no action taken at this time.
